- WATER, Watershed Assoc. of the Tellico Reservoir –Contact: Jeff Rausch. TLife Guidelines were sent. Subscription paid. Web Page up and running and 1 event posted.
- Conservative Club: Completely revamped web site up and linked to homepage. 3 events posted to Calendar. Subscription paid.
- Firearm Club:
 - 3/12/22 GMT had an indepth discussion with Patrick O'Malley (unclepat442@live.com) about bringing this club on board and at what level. We further discussed the structure needed for a web page. Ginger tasked them with looking at other web pages and see if there is a club that we can use as a base. Ginger suggested they go with a Silver subscription based on the number of events they hold. GMT sent them the TLife guidelines. Have not heard from them since.

Normal Event Processing

The first of March was extremely busy. The last two weeks have been quieter.

- Lori Dramm will check with Patrick O'Malley to see if they've made any decision.
- Discussion from Gary Wheelock about co-sponsorship events and event registration. Result of discussion: Event registration is restricted solely to members of the club holding the event. Even with events co-sponsored by New Villagers and HOA, each club holds their own registration.
- Ken Litke concern that a picture on the Conservative Club web page. Felt it was too political and put to the group. Agreement was made.

Suzanne presented how the video update was going

- Showed rack cards branded as TellicoLife and note to ask folks to contact us if empty.
- New Villagers are revamping the logo. They need more time redo logo.
- Suzanne will wait until the New Villagers have a new logo to reprint rack cards.
- KC to check with Gary at end of April regarding progress with the logo.
- Ken suggested that we put a QR code on the rack cards. Agreement reached.
- TODO: Suzanne/KC to put QR code and new logo on the rack cards, for the next printing.
- Videos in process: Login Help, Editing your Profile and How to register for an event
- Suzanne shared the pilot video she's been working on to demonstrate "Member Login Signup", if you are having trouble.
- Discussion about how adding another video regarding initial member join process. Need
 to tell people the concept of household and adding the members of the household
 when people originally sign up. Suzanne needs to keep the video to 3 minutes. She will
 get with Marcia about how to script the proposed video. GMT will send Suzanne the pdf
 she created on how to sign up.

All agreed the first video looks great.

Goals for 2022 - Opt Out Email

- Reduce number of residents who opt out of TLife communications
- Survey Sent on 3/27 to 306 TLife members, 92 responded
- Results:
 - Bad email address: 5
 - Moved: 55
 - Wanted to Opt Out: 3
 - Opt Out was a mistake: 29
 - No Response: 214

The 29 which were a mistake, KC resubscribed them.

KC: Will look at those folks who have 0 engagement with TellicoLife and will remove them.

Gary discussed issues with bounced emails and phone numbers in errors. Last year, KC asked the NV membership team to double check the bounced emails and phone numbers, and see if those could be updated.

Marcia said that it was the normal process to show the name, phone number and address on the confirmation emails for all events. Are we still doing that?

To do: Check that we are confirming names and phone numbers on Event confirmation.

Marsha presented the Powerpoint deck of the information that she, Ken and Beth discussed. There was discussion on the next steps to prepare to approach the POA board regarding making TellicoLife an amenity for the village. This is an initial draft and not ready for publication.
